This was done through qualitative data analysis where each document was analysed in relation to the theories stated to discover how the corporations use them during the processes of prosecution. This research cannot be generalised to all corporate prosecutions but can act as a starting point for further research into this field.It should be noted that all of the information in this text was accurate at the time of writing in 2006/2007.
